PERKINS JOB PLACEMENT PERFORMANCE INDICATOR OVERVIEW

Overview

Each year Cayuga Community College does a submission to the New York State Education Department (NYSED) with details about students enrolled in Career & Technical Education (CTE) programs during the previous academic year. The 2020-21 submission showed that Cayuga had 1,045 enrollments in CTE programs during the 2019-20 academic year. Of these enrollments, 174 were awarded a degree in a CTE program and considered completers.

The following CTE programs were represented by these completers:

- Criminal Justice: Corrections--AAS (8)

Job Placement

The 2020-21 submission reports the job placement status of completers six months following graduation from Cayuga. Of the 174 completers, job placement information for 120 of the graduates was ascertained. Of those completers with known placement information, 79.2% (95 completers) reported being employed. Of those employed, 52.6% (50) reported being employed in a program-related position. For the 2019-20 submission, 59.3% of completers reported being employed (118 out of 199 completers) and 62.7% (74) reported being employed in a program-related position.

Below is placement information for the programs with the highest number of completions from the 2020-21 submission:

- Nursing—AAS: 100% (25 out of 25) were employed; all were employed in a program-related position
- Business Administration—AAS: 63.6% (14 out of 22) were employed; 21.4% (3) in a programrelated position
- Criminal Justice: Police—AAS: 92.9% (13 out of 14) were employed; 30.8% (4) in a programrelated position
- Business Administration—AS: 78.6% (11 out of 14) were employed; 36.4% (4) in a programrelated position

Continuing Education Status

The 2020-21 submission also reports the continuing education status of completers. Student tracking data indicates that of the 174 completers, 27.0% (47) were subsequently enrolled in college following the completion of their CTE program at Cayuga. Of those with subsequent college enrollment, 83.0% were either not employed (15), not employed in a program-related position (12), or had an unknown employment status (12). For the 2019-20 submission 40.3% (93 out of 231 completers) were subsequently enrolled in college following the completion of their CTE program and 91.4% were either not employed (65), not employed in a program-related position (12) or had an unknown employment status (8).
