A LETTER FROM THE PRESIDENT AND EXECUTIVE DIRECTOR

THE CAYUGA COUNTY COMMUNITY COLLEGE FOUNDATION, INC.

Dear Friends and Supporters,

We are happy to report to our donors, investors and supporters that the Cayuga County Community College Foundation continues a long tradition of supporting Cayuga Community College. The Foundation started with an initial corpus of \$1,572 in 1982 that has now grown to over \$14.8 million dollars. This careful fiduciary management has occurred, while at the same time annually awarding the College, our faculty, staff and most importantly, our students, hundreds of thousands of dollars each year to invest in educational opportunities.

This past year our investments have ranged from our Presidential Scholarships that provide a free high-quality education to our best and brightest area high school students and supporting faculty projects each summer for intensive Academic Fellowships to educational opportunities through the arts, underwriting theatrical performances and providing stipends to students who may not be able to financially join the National Phi Theta Kappa Honor Society, an association that helps them access other financial aid, to continue their education after they leave Cayuga. Collectively these investments encourage enrollment, support both our students and faculty and enhance our college community.

The Foundation has taken the view and implemented the practice, when possible, to make investments that leverage outside funds to create opportunities for our College and its students. The largest single investment of this type in years has been the September 2019 purchase of the River Glen Plaza adjacent to our Fulton Campus, to allow for the expansion of credit and non-credit courses. This investment has its expenses covered by the College and SUNY reimbursement, with no cost to the Foundation. After discussions with President Brian Durant, the Foundation agreed, at the end of August 2020, to assist the College in the creation of the Advanced Manufacturing Institute on the Fulton Campus that will double its investment with a match from SUNY.

For more than half of the 2019-2020 Academic and Fiscal year Cayuga, the Foundation and the nation faced the COVID-19 Pandemic. Immediate priorities changed, and our focus became the dire needs of our students. For example, while we are still fundraising for our 88 Keys Campaign to replace the College's nearly six decade old piano, we have had to extend that effort into 2020-2021. Rather we have been presented with unique opportunities in this crisis to assist our students. A prime example was that we were able to help leverage a challenge presented by the SUNY Impact Foundation with the assistance of an anonymous out of area donor. In just a two and half month period, we raised more than \$28,000 to go directly, by the end of December 2020, to help students, who, due to the Pandemic, had food security, housing, medical or transportation needs that would have prevented them from continuing their studies.

It is support like this, that allows our students, faculty and College to grow and thrive. On behalf of the Foundation Board and Staff and Cayuga Community College, we want to thank you for your continued support of our efforts to continue to assist our faculty, staff and students.





OSCILLOSCOPES PURCHASED FOR FULTON LAB



Through the generosity of the Myron Sullivan Memorial Fund, the College has been gifted 18 state-of-the-art "Digital Storage Oscilloscopes" for the Physics-Technology-Engineering Lab Room on the Fulton Campus. Oscilloscopes are a laboratory instrument that is commonly used to display and analyze the waveform of electronic signals. The device draws a graph of the instantaneous signal voltage as a function of time. The Tektronix equipment purchased is what students, entering the industry, will most likely find at their employer.

The Fulton campus is looking to expand offerings in Physics-Technology Engineering classes and having updated-modern equipment, such as the Oscilloscopes, in the labs will be critical to this expansion.



SUPPORT FOR ATHLETICS PROGRAM

In 2019-20, the Cayuga County Community College Foundation provided funding to the Athletic Program to help meet several goals. The Athletic Department, like so many other programs, is challenged each year to "do more with less" and this year that included meeting compliance through mandated trainings and providing additional academic support for our athletes. In addition, part of the grant was used to increase awareness of the newly refurbished Falcon Park and boost attendance at our sporting events. These efforts foster pride in our College and team spirit on campus, and throughout the Cayuga Community College community.





EAGLE SCOUT PROJECT – NATURE TRAIL

In the Fall of 2019, local teen Ethan Caputa was awarded Eagle Scout status after completing an expansive project in the Cayuga Nature Trail, a highly utilized trail and nature preserve behind the Auburn Campus. Mr. Caputa approached the Foundation for guidance, which expanded to include a partnership with him and involvement of long-time supporters of the Cayuga Nature Trail, the Goldman family. The project included new signage, bat and bird boxes along the trail, and culminated with the installation of a new wooden swing overlooking a picturesque pond, courtesy of the Foundation. In addition to the Goldmans and the Foundation, Mr. Caputa was assisted by his fellow scouts of Troop 11, the Cub Scouts of Pack 11, and their scout leaders.

ANNUAL HOLIDAY CRAFT FAIR

In 2017 the Foundation took over running the Annual Holiday Craft Fair from the College. In both 2018 and 2019, the Fair operated at full capacity with over 150 vendors registered. Food trucks and the College's Subway Restaurant provided refreshments. The Foundation employed 20 College students to assist with the Craft Fair, which, in its 46th year, attracts over 3,000 visitors each year.

FOUNDATION ASSISTS WITH 3 FUTURE NEEDS OF FULTON CAMPUS



The College Foundation, through a subsidiary, CFRG NewCo, purchased the remaining River Glenn Plaza in Fulton adjacent to the Fulton Campus in September of 2019. After careful consideration, the Foundation unanimously agreed to purchase the plaza space that includes more than 127,000 square feet, including a now vacated K-Mart. The Foundation made the decision, in consultation with College leadership, to secure the facility to allow the College to better plan future expansion on the Fulton Campus and reduce its financial liabilities both in the short and long term.

The College currently has a Dental Hygienist, Medical Assistant and OTA Lab in separate store fronts, as well as housing the College's Student Center, Event's Center, the Faculty Student Association's Barnes and Noble Bookstore and a Fitness Center for students, which was previously funded by the Foundation.

The College Foundation is assisting the College with its next phase of programming on the Fulton Campus - the creation of the Advanced Manufacturing Institute (AMI). In Phase 1, the AMI will occupy the former Dollar Tree storefront of more than 7,500 square feet. In cooperation with economic development professionals and local manufacturing operations, the new AMI will offer a state of the art learning facility for the area's manufacturers. Many of those companies that will utilize the AMI have already given generously to the College Foundation with the College Foundation also contributing nearly \$100,000 that will be used to complete Phase 1 by the Spring of 2021, allowing the College to leverage SUNY Funds.

In August 2020, the Cayuga Community College Nursing Program was named best Associate Degree Nursing Program in New York State and one of the best in the country by RNcareers.org. This organization, comprised of nurse educators and practitioners, helps nursing students advance their careers. Their methodology for the ranking compared data on 55 degree programs from state nursing boards, Federal entities, the National Council Licensure Examination pass rates and other accreditation information.

In 2019, Cayuga announced a partnership with SUNY Upstate Medical University to allow students to earn their bachelor's degree at SUNY Upstate without having to submit new applications.

INVESTING IN THE NURSING PROGRAM

For the 2020-2021 Academic Year, Cayuga County Nursing Scholarships were awarded to nursing students from Cayuga County. The funds will offset the cost of their education through tuition aid, as well as related educational expenses for labs and clinical requirements. This funding was made possible by the D. E. French Foundation and the Stanley W. Metcalf Foundation.

FACULTY SUMMER FELLOWSHIPS

Special Projects and Development Grants provide faculty and staff members the opportunity to attend conferences, explore possible new programs and pursue professional development in their fields. Recently funded projects include:

Abu Badruddin, Professor of GIS, attended the 2019 Education GIS Conference in San Diego. The Conference provided opportunities to learn about recent advances in GIS technology, receive software training on new products and gain access to educational resources from ESRI (Environmental Systems Research Institute).

John Campbell, Professor of Drafting, (pictured with his students above), developed a course entitled "Advanced CAD/CAM – MMT 208", a 4 credit hour that provides the knowledge and skills necessary for effective designing and drafting of tools, dies and fixtures used for stamping, forming, shaping and inspecting component parts as well as products.

William DeMott, Associate Professor of Art, created eleven illustrated PowerPoint slide lectures on art topics, and fifteen Art History PowerPoint slides. These short illustrated lectures on a variey of topics can be used in art and art history classes, borrowed by other art instructors and possibly instructors of classes outside of art.

Brenda Forrest, MS RN FNP CNS, Professor of Nursing, and Kassie McGrath, MS RN, Assistant Professor of Nursing, developed and integrated the patient simulations for maternity post-partum hemorrhage and pediatric asthma, acute respiratory distress, for the nursing students to participate in as part of learning experiences they would not, likely, experience in a clinical setting.

Melissa Johnson, Associate Professor of Art, attended a week-long course on Book Art at Wells College, and a class on Sauri Weaving, taught by Karen Pardee. She is one of four registered Saori (free form weaving) instructors located in the Northeast U.S.

PRESTIGIOUS NYC THEATRE COMPANY PERFORMS 3 SHOWS IN CAYUGA'S BISGROVE THEATRE




An award-winning New York City theatre company committed to performing dramas with an eye on positive social change performed three plays in February at Ca yuga Community College. The New Perspectives Theatre Company (NPTC), under the direction of Cayuga alum Melody Brooks, performed "Oh My, Goodness," "Our Lady of Broad Street," and "Suffragists from the Stage" at Cayuga's Irene A. Bisgrove Theatre in Auburn. The Ca yuga County Community College Foundation's Cultural Enrichment Fund sponsored the performances.

The dramas merged serious topics and historical facts to create entertaining plays addressing past and current social issues. The three plays featured a variety of topics and techniques. "Oh My, Goodness," by Cayenne Douglass, is based on a real event about a random connection tying two strangers together in a life-or-death struggle despite their being thousands of miles apart. "Our Lady of Broad Street," by Jane Denitz Smith, tells how the Virgin of Guadalupe begins appearing to a New York architect after she restores a historic hotel. The "Suffragists from the Stage," originally created by Mari Lyn Henry, and further developed by Melody Brooks, details the Women's Suffrage Movement and the role theatre women played in women earning the right to vote. The performance used the words of prominent suffragists to tell the story and included a question and answer session between the audience and cast.

COLLEGE FOUNDATION'S FIRST CHAIR PASSES AWAY



Dr. Joseph K. Karpinski Sr., D.D.S, the College Foundation's first Chair passed away on April 7th, 2020 at the age of 96 in Auburn. Dr. Karpinski, a gregarious personality and local philanthropic leader helped to found the College Foundation when it was formed in the Spring of 1982, with other community leaders that included William F. Allyn, Dr. Arthur Bellinzoni, John "Jack" Bisgrove, Dr. Bruce Dearing, Peter J. Emerson, Joseph F. Ganey, Marion Kennedy, William Komanecky, Senator George Metcalf, May Minturn Osborne, Assemblyman Lloyd S. Riford, Robert J. Tarnow and Ronald West.

A member of the College Board of Trustees at the time, he agreed to take a leadership role with Daniel C. Labeille, then a professor of theater and Chairman of the Humanities Department, in founding the Foundation, which would have Dr. Karpinski as its first President and Mr. Labeille as its first Executive Director. Starting with assets of less than \$175,000 at the end of 1982, the Foundation manages nearly \$15 million currently. Dr. Karpinski served on the Foundation Board until 1986, when he was made its first life-long honorary member.

Dr. Karpinski, with his late wife, "Honey", was one of the College's greatest cheerleaders both supporting it with his volunteer leadership and also philanthropically. He and his family have had a long history of supporting the College with his brother John J. Karpinski, being a member of the original Board of Trustees for Auburn Community College and continuing on with his nephew, local attorney John Karpinski, serving nearly three decades on the Board of Trustees, retiring from the Board during the 2016/2017 Academic Year.

Among the philanthropic gifts Dr. Karpinski made to the College included financing for several family scholarships and also the rotunda, on the Auburn Campus, named the Dr. Joseph F. Karpinski Sr. Rotunda and dedicated in 2005. Even in his final year, Dr. Karpinski had CCC in his thoughts by making one more sizable gift to the College.

These Scholarships are available to all students who graduate in the top 20% of their high school class and provide full tuition for two years at CCC, as long as the student maintains a 3.0 GPA and attends full time. All Cayuga Presidential Scholarship recipients can complete the first two years of their college education without spending a penny in tuition. The Cayuga Presidential Scholarships reward students for consistently demonstrating strong academic performance. It also brings students to Cayuga who participate in honors programs, student government and other leadership positions.
