A LETTER FROM THE PRESIDENT AND EXECUTIVE DIRECTOR

THE CAYUGA COUNTY COMMUNITY COLLEGE FOUNDATION, INC.

Dear Friends and Supporters,

Thirty-nine years ago the College Foundation started with an initial corpus of \$1,572 and we are happy to report that at the end of our fiscal year on August 31st, 2021 we have grown the endowment to over \$18 million, substantially up from last year's \$14.8 million. This has been done through careful fiduciary management by our Board of Directors and Staff. At the same time, we continually award hundreds of thousands of dollars annually to help with the work of our faculty, staff and most importantly, our students, who receive hundreds of thousands of dollars in support to further their academic work at Cayuga.

While we all continue to deal with the challenges posed by COVID-19, the Foundation continues its long tradition of investing in our College, students, faculty and staff as showcased in this Annual Report. The investments range from our commitment to scholarships and commencement awards to programs and projects that directly help our students large and small. Whether it be underwriting the inaugural Cayuga Film Festival and helping the Harlequin Theatre Group host a reunion, to purchasing a refrigerator for the student food pantry, or the investment in a new pitching machine for our baseball team, the Foundation is committed to making a difference.

While work continues to bring to completion our investment in the Advanced Manufacturing Institute on the Fulton Campus and the new Boston Steinway Piano has arrived on our Auburn Campus to help with our Music Program, the Foundation made several major decisions in the Summer of 2021 that, we believe, will make an even greater difference for Cayuga and our communities. Among the investment decisions made are:

• Created a \$20,000 Challenge Grant to raise funds for our Student Emergency Fund (SEF). The Fund will assist students in need, especially during the continuing pandemic, where other funds may not be able to help with items such as childcare, housing, health/dental care and/or transportation.

• Increased by 25%, the amount of money that is available from the Foundation Endowment, based on its growth, for scholarships for the 2022-2023 Academic Year. The College's Student Financial Services office is packaging scholarships with this increase to recruit more students to come to Cayuga.

• Increased by 50%, the funds available for the next incoming group of Presidential Scholars for 2022-2023, which will cover the full cost of tuition after other scholarships, Pell and TAP are accounted for. The hope is to continue to assist the College in recruiting top academic high school students from Cayuga and Oswego counties who also show a commitment to their extracurricular community activities.

• Approved our next major capital investment with funding an HVAC system for Spartan Hall and also updating the HVAC system at Bourke Memorial Library to make it more efficient and less costly to maintain. This investment of \$225,000 will allow the College to better serve our students, and, as one of our Board Members made it clear at their meeting," ... be of great benefit to the greater Auburn/Cayuga County Community". This investment also leverages State funds to allow for this large project. We hope that it can be installed before the start of the 2022-2023 Academic Year.

All of the above only happens with the continued support of our donors, the local philanthropic community and area businesses who continue to assist our faculty, staff and students. On behalf of the Foundation Board, our Staff and Cayuga Community College, we want to thank you for your continued support.





For the Film Festival's inaugural year, over 50 submissions were screened and nine winners announced in categories that included narrative, documentary and animated short films. "The festival provides Cayuga

students with exposure to the work of new and emerging filmmakers and with the encouragement they need to continue their film and video studies at the bachelor's level," said Keeler. The 2022 Cayuga Film Festival is currently open for submissions.

PTK Students Make A Difference

For the last two years the College Foundation has helped to underwrite the student initiation fees for Phi Theta Kappa. In the Fall of 2021 over fifty students have joined the PTK National Honors Society. The Foundation award ed seventeen scholarships for the membership dues for students in need.

The Foundation is delighted to assist our students to get into PTK, that allows them access to \$250 million in scholarships for transfer students who choose to contin ue their education beyond Cayuga. Just as importantly, the Foundation is happy to give access to PTK that also sees our students help our communities. CAYUGA'S NURSING PROGRAM EARNS TOP GRADE FROM NURSING SCHOOLS ALMANAC

In November 2021 Nursing Schools Almanac rated Cayuga Community College's Nursing the top associate's degree program for nursing in New York. In their online ratings, Nursing Schools Almanac rated Cayuga's program the best among almost 70 associate degree programs in New York. The ratings are based on an evaluation of each college's record of graduates passing the National Council Licensure Examination for Registered Nurses (NCLEX) on their first attempt. In their statewide rankings, Nursing Schools Almanac tracked NCLEX pass rates for most colleges from 2011 through 2020. Aspiring registered nurses are required to pass the NCLEX before they begin practicing.

Of associate degree programs in New York, Cayuga's pass rate of 98.1 percent for first-time test-takers was the top score. From 2011 through 2020, 405 of the 413 graduates from Cayuga's program passed the NCLEX on their first try. Cayuga's two-year Nursing program emphasizes professional standards, clinical judgments based on evidence-based practice, patient-centered care and advocacy, leadership and communication. Students experience a variety of clinical settings, preparing them to provide care for patients of any age.

NURSING STUDENTS BENEFIT FROM SCHOLARSHIPS

For the 2021-2022 Academic Year, Cayuga County Nursing Scholarships were awarded to first year nursing students from Cayuga County. The funds will offset the cost of their education through tuition aid, as well as related educational expenses for labs and clinical requirements. This funding was made possible by the D. E. French Foundation and the Stanley W. Metcalf Foundation.

The Cayuga Presidential Scholarship are for outstanding students from high schools in Cayuga and Oswego counties, including private schools. Students from the Jordan-Elbridge, Skaneateles and Red Creek school districts are also eligible. These Scholarships are available to all students who graduate in the top 20% of their high school as long as the student maintains a 3.0 GPA and attends full time. All Cayuga Presidential Scholarship recipients can complete the first two years of their college education without spending a dime in tuition. The Cayuga Presidential Scholarships reward students who participate in honors programs, student government and other leadership positions. These students serve to raise the academic bar in every classroom, serving as examples for their peers.

FACULTY SUMMER FELLOWSHIPS

Special Projects and Development Grants provide faculty and staff members the opportunity to attend conferences, explore possible new programs and pursue professional development in their fields. Recently funded projects include:



Danielle Moran and Delicia Weatherstone, Professors of Nursing, completed a project entitled, "Integrating NextGen NCLEX into the classroom setting using case studies and Docucare". As a result of this project, they learned about the major changes to the NCLEX exam, identified

software and a plan to implement these new question types in the course and develop new teaching strategies to implement in the classroom setting to enhance the student's clinical judgment skills and help them pass the new NCLEX exam. The 2021 Fall incoming nursing students will be the first cohort to take this new exam, which is a major shift from the current exam. Registered nurses are required to pass the NCLEX before they begin practicing.



Melissa Johnson,

Associate Professor of Art, completed a project entitled, "Sustainable Art Materials and Practices". She studied natural dyeing with fiber artist, author and leader in natural dyeing, Katrina Rodabaugh and attended an individual intensive training with

Kirsten Kurtz, MS, soil artist and Manager of the Cornell University Soil Health Laboratory. In addition to her own learning as an artist, Prof. Johnson will be able to incorporate these experiences into her teaching. She is able to replace chemically-based pigments with natural alternatives, thereby encouraging students to be aware of the impact of art supplies on the environment. She is developing a visiting artist lecture and demonstration with Ms. Kurtz. This will be an excellent match to the following courses: "Special Topics – Contemporary and Sustainable Art Practices" and "Art 104 – Painting 1".

MARTIN, SMITH, WHITE RECEIVE 2021 ALUMNI AWARDS

The COVID-19 pandemic may have prevented the traditional Alumni Awards celebration this year, but it didn't deter the Alumni Association Board from announcing its 2021 award winners this spring.

Gerald E. Martin '67

Mr. Martin graduated from Auburn Community College in 1967 with an associate's degree in Business Administration, and from SUNY Brockport with a major in economics and a minor in history.

When he realized teaching was his true calling, he earned his Master of Science in Education from SUNY Cortland. His career spanned more than 40 years, most of it as a beloved history teacher at Auburn High School. He also taught advanced coursework in history and political science at Syracuse University and SUNY Oswego, as well as history courses for Cayuga.

He is credited with establishing the Auburn High School History Club, and produced history-themed plays and trivia shows on the school's public access television station. Throughout his career, Mr. Martin organized several trips with students, parents and faculty to cities of historic significance including Boston, New York City, Philadelphia, Washington, D.C., and Williamsburg. The 2021 recipients of the annual award are Gerald Martin '73, Robert Smith, Esq. '77, and Thomas White '92. The recipients will be honored by the Alumni Association at an upcoming celebration.

"Gerry Martin has taught thousands of students, giving many their first exposure to higher education," said



Guy Cosentino, Executive Director of the College Foundation, who nominated him. "While he has been a great educator, he can also be

known as the 'Great Influencer.' His focus was always on his students and getting them to do their best. Always professional in dress and address, he respected his students and his profession. In return, his students not only respected him, but it can easily be said, many adored him."

He's received several awards in his career, including the Walmart Teacher of the Year, the Cayuga County Bar Association Liberty Bell Award, and was named a Cornell University Merrill Presidential Scholar Outstanding Educator in 2005.

Mr. White earned an associate's degree in both Broadcasting and in Broadcast Technology in 1992. Upon graduation, he started work as a master control operator for Newchannels, which evolved into Time Warner and then Spectrum, eventually being named Director of Operations for Time Warner Sports. He has done freelance work for ESPN, FOX, CBS, NBC MLB and other networks over the years. In 2017 he became the broadcast engineer for athletics at Syracuse University and helped initiate the new ACC Network that currently broadcasts sports events for the ACC Conference. Mr. White is a member of the CCC/Telcom Advisory Board. He has mentored numerous students and graduates, providing internships and help establishing their careers. He is a frequent visitor to the College and serves as a guest lecturer.

Rick Emanuel



Rick Emanuel of Elmira, died unexpectedly on April 15th at his home. He was 55 years old.

Mr. Emanuel was publisher of *The Citizen*, Auburn's hometown newspaper, from 1998 through 2008 and returned in 2013 to serve as interim publisher. He also worked as publisher at the *Post-Star* in Glens Falls and the *Star-Gazette* in his hometown of Elmira. At the time of his passing, he was senior director of sales for Gannett/USA Today Network.

While in Auburn, as in the other communities he lived, he was an active volunteer and a champion of several initiatives. "I spent time working on community projects not because I was told to but because I always wanted to better the place where my children were growing up and my family lived," Emanuel wrote in a 2016 column he contributed for *The Citizen*'s 200th anniversary.

Mr. Emanuel served as President of the Cayuga Community College Foundation in 2010. "He was always pushing Auburn and Cayuga County to do better," said Guy Cosentino, Executive Director said. "He was just a compassionate soul."

Mr. Emanuel is survived by Kelly Turk Emanuel; daughter, Alexandra Ruggiero with husband, Nicholas; son, Eric Emanuel and grandchildren Luca and Nico Ruggerio.

Dr. Arthur H. Foresman, MD



Arthur H. Foresman, M.D. of Auburn, died on December 8th, 2020 at the age of 87. Dr. Foresman was a Director of the Cayuga County Community College Foundation beginning in the late 1990's, and serving through 2004. Dr. Foresman was a graduate of Franklin and Marshall College, and Temple University Medical School. He was a member of Phi Kappa Tau Fraternity and Phi Chi Medical Society and AOA, the Medical Honor Society. In 1965, he started his dermatology practice in Auburn, joined by his daughter Pamela L. Foresman, M.D. in 1993. Dr. Foresman retired in 2002.

In addition to his service to the Foundation, Dr. Foresman was president of the Cayuga County Medical Society, Cayuga County Boards of Health and Mental Health, Board Member for the Neighborhood House, the YMCA, Cayuga County Arts Council, a deacon and elder of Westminster Presbyterian Church, and a member of the Kiwanis Club. Dr. Foresman was predeceased by his wife of 64 years, Joanne Philbrook Foresman and his son, William H. Foresman, M.D. He is survived by three children, Jeffrey S., Pamela L. Foresman Brundage (Brian), and Robert M. (Ludmila); and by 10 grandchildren.

The Foresman Family have been supporters of Cayuga Community College for many years, and established the Foresman Family Scholarship in 2006. This provides an annual scholarship to an incoming freshman.

John McLane

Former Cayuga County Community **College Foundation President John** "Jack" McLane passed away on February 20, 2021. He served on the Foundation Board from 1998 to 2007, serving in a variety of capacities. Mr. McLane was a graduate of Mount Carmel High School, and received a Bachelor of Arts Degree from Niagara University and his Juris Doctor Degree, with honors, from Columbia University Law School in 1968. He joined in the private practice of law with his father-in-law, Edward T. Boyle and partners, in 1970. He practiced law with the firm, which later became Boyle and Anderson, P.C. for more than 50 years.

His community service and charitable work included Cayuga County Big Brothers, American Red Cross, YMCA-WEIU, Cayuga County United Way, Central New York Planning and Development Board, and Schweinfurth Memorial Arts Center. At the time of his passing, he was President



of the Columbian Foundation and officer for both the D.E. French and Stanley Metcalf foundations. Foundation Executive Director Guy Thomas Cosentino said "Jack McLane was not only the President of the Foundation Board, but a great supporter of Cayuga, professionally as well as personally and philanthropically, with his wife Kathy. He was a cheerleader for Cayuga, knowing it was a true community asset."

During his tenure on the College Foundation Board he not only served on the Executive and Membership committees, but was also a member of the Auburn Campaign Steering Committee.

Mr. McLane received many professional awards and recognition from his peers during his career, including the United States Court Achievement Award and was listed in "Who's Who in American Law." He was annually chosen by his peers as one of the "Best Lawyers in America" from 2013 to 2021, and was also chosen to serve on the Merit Selection Panel for the Selection and Appointment of United States Magistrate Judges for the U.S. District Court.

He is survived by his wife of 52 years, Kathy (Boyle) McLane; children Daniel McLane and his wife Heather; Molly McLane and her husband Christopher Valli; Douglas McLane and his wife Celia; and Mary Claire Pineau and her husband Mark; as well as 12 grandchildren.
