## How the Alumni Association Came to Be... **50 Years of Life Changing Opportunities**

2009 Marks the 50th Anniversary of the ACC/CCC Alumni Association. Here is a brief history of the formation of the Association.

In 1953, the charter class of Auburn Community College had 69 students in the former James Street Elementary School. The first issue of the Collegian, the college student newspaper, was printed in October 1953 and in January 1954, Auburn Community

College was dedicated. Commencement for ACC's first graduating class was held in June 1955. In November 1957, on a 40-acre site on

Franklin Street in Auburn, ground was broken for a new campus. ACC moved to that site in August of 1959.

Along with a new campus,

ACC had a growing number of alumni, so an association was founded "to work actively

and effectively to advance the interest of the College, its students, and alumni." Events and activities were planned to keep these new alums connected with Auburn and ACC.

Several years later, following the College's transition to county sponsorship in 1975, the association was reorganized, and in 1980 it was incorporated and renamed the Auburn/Cayuga County Community College Alumni Association, Inc. Despite good intention, activity, however, was sporadic.

In the mid-1980s, the ACC/CCC Alumni Board was coordinated by Jim Cranfield, a member of the college's Physical CONTINUED PAGE 6

#### mber Graduation Ceremony CCC Holds First Dece

In recent years, the ACC/CCC Alumni Association has hosted a December Recognition Ceremony to recognize students who had completed their course requirements in December. It wasn't an actual graduation ceremony, simply an opportunity to celebrate their accomplishment. Often, when students complete these requirements, they transfer to a four-year school, get jobs, even move away. Many may not be able to return for the traditional May ceremony or choose not to participate. The Alumni Association sponsored a "December Recognition" event for these students, invited a keynote alumni speaker, and hosted a reception for the students and their families.

In December 2007, new CCC President Daniel Larson attended his first December Recognition. He liked

the program enough to put a plan into action to make it a real graduation. A **Commencement Exercises Committee** was formed under the leadership of Mel Brown, director of human resources, who has organized May graduation ceremonies for close to 30 years. Other committee members included Bob Frame, coordinator of theatre operations, and Louise Wilson, director of alumni affairs. With assistance from Michael Pastore, CCC registrar, as well as various other college departments, plans went forward and the first December Graduation was set for December 12, 2008, the traditional date the December Recognition would have been held.

The ceremony did not include the usual pomp and circumstance of caps and gowns and faculty in regalia. But it did allow each graduate the opportunity to "walk" across the stage of the Irene A. Bisgrove Community Theatre to receive their tassel. The new grads were offered the opportunity to participate in December or the traditional May ceremony, and they still have the option to attend the May event

Director of the CCC Library Marc Wildman was the pianist and Martha Reutlinger, Class of 2009, sang the National Anthem. Following an Invocation by College Chaplain, Reverend Floyd Duger, welcome addresses were given by Dr. Larson and Jeffrey Edwards, chair of the College

Board of Trustees. John Lamphere, president of the ACC/CCC Alumni Association and a faculty member, offered a message to our new alumni. Guest speaker was Stanley J. Kott '68. Mr. Kott was named to the CCC Board of Trustees in October 2008, and is currently the CEO of Montpelier Underwriting, Inc.

In his address, Mr. Kott spoke of the year he graduated from ACC. "It was June, 1968 and Robert Kennedy had been assassinated, the war in Viet Nam was continuing and soldiers and civilians were dying. On college campuses across the country students were protesting the war; civil rights were still being debated and defended; Martin Luther King had been killed only two months earlier. Change was being promised. There was no cable TV; personal computers were not yet a reality; fax machines were not yet invented; and no one had anything but a corded, probably rotary dial telephone. Most of us had to get up from our chair to turn the TV channel. It was a troubled time and yet it was a good time because there was, like toda hope for a better future." Mr. Kott's final advice was: "be an optimist, work hard, learn all the time, have hope, do the right thing and follow your heart." Advice that withstands the test of time.

Dr. Deborah Moeckel, vice president of academic and student affairs/dean of the faculty, along with Jeffrey Hoffman,

executive director of the College Foundation, presented candidates for degrees which were conferred by Dr. Larson.

The Alumni Association hosted a reception for the new alumni, their family and guests. Association board members Judy Campanella, John Lamphere, John McLeod, Debbi Purcell, Paul Ringwood and Director Louise Wilson served refreshments and sweets, including a cake with the inscription "Congratulations, You're Alumni Now!" at the festivities held in the student lounge. Christopher Molloy provided musical entertainment on electric harp.





Have you ever noticed that as much as things change, they stay the same? This also holds true when looking back over the first 50 years of the ACC/CCC Alumni Association.

#### A Message from CCC President Daniel Larson

Greetings to ACC/CCC Alumni and Friends,

I'm writing this letter at the beginning of the Spring semester, after a Fall that brought us a spirited election campaign and one of the most challenging economic times in the history of our country. But, change and transition are in the wind, not only on the political scene but also at the College.

As you know, a good part of our funding comes through the New York State budget. The Governor has proposed substantial cuts for many sectors, and the College is included in them. We continue to work with the SUNY System and with our legislative delegation to mitigate the depth of those cuts. My hope is that they will be lessened by the time the Legislature approves the State budget this Spring. Community colleges run about as lean an operation as can be found in American higher education. A budget cut of the magnitude proposed would have a pronounced negative impact on the College.

Our enrollment continues to be positive, especially with our online, weekend, and high school populations. We know that students want greater flexibility to achieve their educational goals, and we want them to consider the College in their plans. Our expansion of the Fulton Campus will enable us to offer complete programs, not just courses, to address student interests and regional needs. I anticipate that the expansion will be complete within the next 12 months - sooner, if possible. Nursing is one of the programs that we're pleased to expand to the Fulton Campus, which will help to address the continuing need for healthcare employees in the region.

Our search for a new leader at the Fulton Campus resulted in the appointment of Margaret Killoran, currently at Isothermal Community College in North Carolina, as the new Associate Vice-President and Dean of the Fulton Campus. Maggie, with a strong background in student services, adult learning, and enrollment management, will help us in our next steps with the Fulton Campus and greater outreach into Oswego County and the surrounding region. She begins her new position on March 1, so please extend a warm welcome to her.

We continue to make good progress with infusing entrepreneurship education in a variety of academic disciplines. Professor Tom Paczkowski, as our Emerson Endowed Chair, is the College champion in these efforts, along with leading the activities associated with the Kauffman Foundation grant in which we are participants through Syracuse University. The Stardust Entrepreneurial Institute is becoming a reality, with the work on State Street in downtown Auburn now underway. I anticipate that the buildings there will be ready by the time the snow is gone. Once we're ready, be sure to look for a grand opening celebration.

Carla DeShaw joined the College in October as our new Dean of Community Education and Workforce Development. She brings fine experience with these activities from her previous position in the Madison-Oneida-Herkimer BOCES. Already, she's having a positive impact with people she meets and her ideas about engaging the College at a higher level of activity in the region. Please look for the new catalog of course offerings and activities coming from her office, probably even as you read this newsletter. Our goal is to increase the training programs and services provided to area employers and organizations. If you know of a need or an opportunity, please let Carla know.

Spartan athletics have some fine achievements this year. Our women's basketball team is very strong and cleaning up the competition. They're within national rankings, and we have the #1 player in the nation. Our kudos to Pete Liddell, our Athletic Director, and his talented staff and students. We anticipate that the athletic program will

continue to strengthen during the next few years.

We're excited about the continuing development of the Cayuga University Center. As you know, Empire State College long has been a partner with the College, enabling adult students to complete their baccalaureate degrees at the Auburn Campus. In the past few years, Keuka College has joined us, helping to expand the possible program offerings. We're in current discussion with Le Moyne College, SUNY Morrisville, and other institutions about programs they can bring to the College. It's exciting to see that area residents can complete their educational goals without commuting or moving elsewhere. That impact on our communities should be definite and positive. As more details become available, I'll share them with you.

The Spring semester promises to bring the usual full round of activities, programs, and events at the College. I encourage you to participate in them as your interests and schedules allow. The Alumni Association is a valued partner with the College in helping to maintain and strengthen our connections with Cayuga graduates. I appreciate all of your efforts in helping us to do so. We conveniently "forget" that in 1959, a revolutionary named Castro had just taken over Cuba; riots flared in Iraq led by a young guy named Sadaam Hussein; tribes of Hutus and Tutsis fought for control of a new nation called Rwanda; and confrontations between the U.S. and Soviet Union overshadowed a war in some place called Vietnam. On the home front, unemployment was up in 1959, inflation had cut the value of the dollar in half since 1945 and Virginia's Prince Edward County closed its public schools to avoid the "racial mixing" mandated by Brown vs. Board of Education.

In 1959 and 2009, in good times and bad, in prosperity and recession, Auburn/Cayuga Community College and our Alumni Association have been there to serve the people of our communities. ## Alumnus Stan Kott '68 Joins CCC Board of Trustees

On the day he was born, Stanley J. Kott's uncle proclaimed, "We will call him Stas' (Polish for Stanley)." And thus Stanley J. Stas' Kott, named after his father, was born into a working-class family in Auburn, NY. Many years later, Stas' has returned to Auburn and his alma mater to serve as one of the newest appointees to the Cayuga Community College's Board of Trustees.

"I remember growing up in Auburn and how hard my parents worked," he recalls. "My uncle owned a restaurant at Five Points and the extended family all worked there and that often meant working seven days a week. By the time I was fourteen, my regular summer 'time off' was Tuesday afternoons. When I wasn't at school, I was home or at work." Although the hours were long, young Stas' loved life. "You were always around family, around friends. It's where I learned to be outgoing and to meet people and to appreciate the true value of hard work", he said.

After graduating from Auburn East High, Stas' could have stayed with the family's restaurant. He decided instead to take the leap into higher education at Auburn Community College. This experience led him to Canisius College and, following a stint of active duty in the National Guard, onto the University of Hartford. He also began his career in insurance as a claims adjustor and then underwriter.

And then, fate stepped in. "I was doing pretty well in my first job, so much so that my firm offered me a promotion to their New York Office," said Stas'. "I politely said 'no thanks' thinking they would not want to lose me. I was wrong; they fired me! As I was leaving work for the last time, I turned to say goodbye to a co-worker and literally bumped into a guy; I almost knocked him over! He was an underwriter for a reinsurer and his company was looking for people. I was hired within one week and the rest is, as they say, history."

From that point on, it has been an upward journey for Stas' Kott. Today he serves as CEO of Montpelier U.S. Holdings. "Our business is high risk insurance and re-insurance," he explains. The parent company is publicly traded on the NYSE and operates companies in Bermuda, London, Switzerland and the U.S. In addition to his success in business, Stas' serves on several boards, including the Board of Trustees of Wells College. He also stays in touch with his family, the truly important aspect of his life.

Stas' Kott's upbringing in Auburn and his time at ACC taught him many things. Most of all, Stas' has grown to be an optimist. "The glass is always half full or perhaps even more," he says. "I believe that envisioning a good result is an important ingredient toward the eventual achievement of any goal. That, and hard work!"

Is Stas' done with his education? No, he says. "A good life is never finished and your education is never complete. Every day is a chance to learn more, to explore the unknown, to become a better person, to test your knowledge and your limits."

Governor David Paterson visited the CCC Campus on Saturday, January 31 to hold one of his Town Hall meetings. He spoke in the Irene A. Bisgrove Community Theatre to a standing room only crowd. The Governor stated that he wanted to give the public an opportunity to discuss New York State's fiscal crisis and the themes of his State of the State Address.

The meeting was open to the public and questions were taken from the floor. The top concerns were the governor's budget cuts and the state's taxing plans and tuition hikes. One of the topics that concerned local residents was the untaxed cigarettes being sold at Native American stores.

CCC President Larson said he only heard positive

Education Department. The board was a group of elected alumni who met, initiated and planned events and programs. 1987 brought a renewed commitment to alumni when Virginia locolano was hired as part-time Director of Alumni Affairs. The first undertaking of the newly organized Alumni Association was to accept a challenge from the Cayuga **County Community College** Foundation. The Association raised \$50,000 in matched gifts in support of Cayuga's capital construction project. Under Ginny's leadership, the Association was able to grow and develop until her retirement. Ginny had the distinction of being named the Association's first Honorary Alumni in 1995 in recognition of her spirit and efforts on behalf of the Alumni Association.

Momentum within the Association continued and Deborah "Mickey" Maywalt Lord '75 was hired as the first full-time director in September 1994. Throughout her tenure Mickey continued to expand the work begun by her predecessor.

Elisabeth Hurley took the helm in April 1998. She involved the Association in a plethora of activities, not only on campus, but within the community. Under Elisabeth's tutelage, the Association garnered a number of achievement awards: Excellence in Alumni Programming 1996-97 from the Chancellor of the State University of New York; The 16th Annual Admissions Advertising Awards Merit Winner for the Association's newsletter Now & Then; The State University of New York Confederation of Alumni Associations award for Alumni Events and Programs and Senior Citizen Enrichment Day; and the Awards for Excellence in Alumni Development and Programming in September

2002. Even after her retirement in 2006, Elisabeth stayed on to complete the edit of her last edition of the *Spartan*.

Deborah Purcell '98 (a 2006 Alumni Award recipient) was hired as a part-time Alumni office staff member and worked rigorously alongside Elisabeth in the many activities and programs they oversaw. Shortly after Elisabeth's retirement, Debbi accepted a full-time position at the Fulton Campus.

The next director was Nancy B. Ranieri. During her short tenure, Nancy and her vivacious personality infused the Alumni Office. Louise Wilson '72 was hired as Debbi's replacement and along with Nancy, created "the Happy Office." Nancy brought flair to the Association and was involved in the first dinner dance presented by the Association in several years. Even though she wasn't an alum, Nancy had strong attachment to CCC and it was with mixed emotions that she left to pursue another career. Nancy was named an Honorary Alumni in 2008.

And here we are today. When Nancy left in January 2008, Louise was named Interim Director of Alumni Affairs until a search committee could name a fulltime successor. After just a few days on the job, Louise submitted her name for consideration. In April 2008, the CCC Foundation named Louise Wilson the 5th Director of Alumni Affairs. Coincidentally, she is a cousin to the first director, Virginia locolano. Louise hopes to continue to build on the foundation laid by her predecessors. The office is still the "Happy Office" and the door is always open for alumni and friends to stop in to chat, look through the archive of ACC/CCC yearbooks or get a tour of the campus. The ACC/ CCC Alumni Association looks forward to another 50 years of Life Changing Opportunities.





#### **Jason Roche**



Jason Roche, Cayuga Community College's class of 1988, and former Telcom adjunct, is a multi-talented video producer, writer and editor as well as a respected broadcast journalist and communication professor. With more than ten years' experience teaching at the college level, Jason has taught nearly two dozen different courses and has proposed and developed curriculum for new courses. Jason has been nominated as teacher of the year, and was a 2003 recipient of the Dean's Award for

Educating for Justice in the Arts and Sciences Classroom. He has advised hundreds of students and has served as moderator and advisor to college newspaper, radio and television clubs. With more than ten years' experience as a broadcast news reporter and anchor, Jason was a member of the WSYR radio news team that won the 2000 Edward R. Murrow National Award for Overall Excellence. Jason is an active member of the Broadcast Education Association and the New York State Chapter of the Academy of Television Arts and Sciences. His scholarship interests include news and convergence, race and gender issues in media, and documentary production. Jason's documentary "One Survivor's Walk" was the recipient of a Communicator Award and a Telly Award.

Jason recently premiered his documentary film, "Willard Chapel: The Tiffany Treasure that Touched the World," at Willard Chapel. In the film, Jason tells the chapel's remarkable storyincluding how the renowned artist Louis Comfort Tiffany completely designed the chapel's interior, and how the building survived three separate scares that could have destroyed it. The film became a labor of love for director, producer and writer Jason Roche who, as a child, attended church services with his family and was baptized in the building. Willard Chapel was once the heart of the sprawling downtown campus of the Auburn Theological Seminary. Graduates of the Seminary became presidents and founders of more than a dozen famous colleges and universities. Frequently faced with financial difficulties, including the Great Depression, the campus in Auburn closed and seminary board members were forced to sell the chapel. In 1957, the small congregation of the Seventh-Day Adventist Church bought Willard Chapel. Once again, more than 30 years later, economic hardship forced members of the congregation to sell their beloved building. In 1988 an antiques dealer bought the building and immediately threatened to dismantle the chapel, auction off the Tiffany art, and turn the building into a strip club. A small group of preservation-minded citizens banded together and formed a plan to save the chapel. "Willard Chapel: The Tiffany Treasure that Touched the World," tells the story of how these volunteers gave their time, money, and energy to save this Tiffany masterpiece from destruction and turn it into a tourist destination and a center for cultural activities.

#### **Frank Borza**

There is no denying the "Forty Under 40" recipients reflect Oswego's economic diversity. They represent the region's most dynamic, successful and community-minded businesspeople. A police officer from Pulaski, a village mayor, a nuclear senior emergency planner, a child care worker, a financial planner, attorneys and several business owners and professionals are part of Oswego County's next generation of leaders, according to Oswego County Business magazine.

One of Cayuga Community College's alums, Terry Matthew Wilbur '08, was among those honored. He graduated cum laude with an associate's degree in criminal justice. At 20 years old, Terry Matthew Wilbur has already taken part in numerous community programs and activities. He is a Hannibal Village trustee, where he devotes about five hours a week. #### **Vincent Gleason**



## **Mike Quigley**

Childhood without a Helmet: Stump City Two by Mike Quigley



In our fall edition, we were pleased to announce that alumnus Mike Quigley '72 had published his first book. It is a true story "with a tad of exaggeration for seasoning" about the origins of his family and growing up in a central New York neighborhood nicknamed Stump City, a few miles north of the village of Skaneateles. Appropriately enough, the novel is called *Stump City*. And like most families, there are

enough tales to fill another book so Mike had penned a follow up called *Childhood without a Helmet: Stump City Two*. The saga continues with the (mis)adventures of young Michael Quigley, set again in that predominantly Irish-American section of Skaneateles Falls, New York. The story roughly parallels the time period of *Stump City*, and focuses on Michael's interactions with his friends and neighbors. Susan Frank Rayne, a family friend who lives in Massachusetts, wrote the book jacket summary which perfectly describes the book: Each vignette recalls a more innocent time when children's activities were unscripted, directed only by a parent's admonitions that, conveniently, seemed always full of loopholes.

It's refreshing to read about simpler times and how much fun children could have without electronics. The story tells of Michael and his mischievous young friends, Davey Walton and Pete Cashin (whose nephew is an alum), and takes us back to the days of daredevil sledding, learning to ride a two-wheeler, and cooking up Halloween pranks. Of course, when left to his own devices, the young Michael never fails to amaze and amuse – witness the conception, execution, and consequences of playing Tarzan in his underwear.

Mike's book shows the reader that parents and other adults were present and fully engaged, and never far from their offspring and ready with hugs, cookies, reprimands, or the belt, as each situation warranted. Ultimately, it is the fabric of community and family that provides the structure in which Michael and his childhood friends grow and thrive.

Greetings, everyone. Allow me to introduce myself. My name is Maggie Killoran and I am the new Associate VP/Dean of the Fulton Campus for Cayuga Community College. I am honored to have been selected to take on this important task, and am very excited to arrive and begin to meet all of the students and employees of the college.

As you can probably tell from my Canadian accent (argh argh) I am not a native to the USA, never mind to New York. However, I have been living in North Carolina for the past five years,

so my accent has morphed into something that is an unlikely combination of Canadian words like "Torono" (instead of Toronto), "a-boot" (instead of about) and great southern favorites such as "y'all" and "reckon." But I'm getting ahead of myself. Let me begin at the beginning.

I was born in Ontario, Canada (I won't bore you with my date of birth) in a small, friendly, blue-collar community where I was raised in a family of thirteen children... of whom eleven (yes, I said eleven) were boys. My father was a plumber and Deacon in the church and my mom was an elementary school secretary and remains one of my biggest fans to this day.

My family was a loving, close-knit group of people who helped to shape my identify, my sense of humor, and instilled in me a strong knowing that my spot as # 9 of 13 was secure and there would always be a place where I belonged. However, there was not much talk of college or university as I grew up. My parents were smart enough, but trade school and high school were as far as they went. So I never really thought about college....I just figured I'd finish high school (hopefully) and get a job. And, at that point, completing high school wasn't looking too good since I was sporting a "D" average by Grade 12. Of course those grades also seemed like a big ole flashing signpost telling me that I'd be better off just avoiding the whole "school" thing.

But life had other plans for me. Four years after high school I met a local family who introduced me to the idea of attending college. I wasn't so convinced, but their support was unwavering, and so, as a first-generation college student, I jumped into my first year of college with eyes wide shut and never looked back. I discovered that not only "could" I do this....but that I "wanted" to do this. I love learning and have the student loans to prove it!

Post university I began my career teaching upgrading in Vancouver, British Columbia to adults whose lives and schooling had derailed and were looking to "get back on the horse." I continued this work in northern British Columbia by opening up an onsite adult learning center for mill workers in a remote community. I really took to this work, partly because I felt at home with the blue-collar crowd in the mills, and partly because I could relate to the students who typically had not done well in high school and were scared to death of humiliation and failure in the classroom. To this crowd, college was a dream as unreachable as winning the lottery, and completing their GED was their first and most significant goal. After working with such students outside of the college system for a-boot (I mean about) five years, I realized I might have something to offer these same students if I could be the person on the inside of the college, welcoming them in. After all, I knew that they were frightened to darken the door of the local college and that something as simple as a quick negative interaction inside those walls was enough to send them running screaming from the building. And so I accepted an opportunity to work at a community college, and for the second time in my life, I never looked back. I have now spent the past ten years in community colleges working in counseling and admissions in one form or another, and have put a priority on user-friendly systems and friendly frontline staff. If learning was my first calling, working in and supporting students into and through the community college system has become my second.

And so, all of that experience and learning has brought me here to the front door of Cayuga Community College's Fulton Campus. I am as excited as I am nervous, and so looking forward to getting to know names and faces at the campus, having time to talk and laugh with students, and to finally join forces with a group of faculty and staff who have dedicated their energy to the success of the Fulton Campus.

- **CREAM OF JALAPENO SOUP** From Jan Baum
- 1 cup Celery 4 cups Chicken Broth 1 cup Onions 4 cups Heavy Cream 1-2 cups Carrots 4-6 tbsp Butter 1 Green Pepper 4 tbsp Cornstarch 1-2 Red Peppers Salt and Pepper 5-10 Jalapeno Peppers 1 <sup>1</sup>/<sub>2</sub> cups of Swiss cheese Potatoes if desired (already boiled) 1 <sup>1</sup>/<sub>2</sub> cups Cheddar Cheese Olive Oil Garlic (optional)

Cut veggies and cook in a few tbsp. of Olive Oil, covered. Add garlic, salt and pepper. When veggies are done, in a separate pot whisk together cornstarch and butter to make roux, slowly add broth and cream while still whisking. When liquids are slightly bubbling, stir in the cheeses. Stir the cooked veggies into the liquid. Cook on low ½ an hour and continue to stir frequently. When I make it, I go by my own taste...if you like it hot, then go for it!

## Dillard honored twice as NJCAA Region III Athlete-of-the-Week; Leads NJCAA in Scoring

Freshman guard Caitlyn Dillard was named NJCAA Region III Female Athleteof-the-Week twice already this season. She was named NJCAA Region III Female Athlete-of-the-Week for her performances against Adirondack and Herkimer in the season's opening weekend in November 2008. That weekend



Caitlyn led the Spartans to a pair of victories over Adirondack CC and Herkimer CCC. She scored 59 points, pulled down 10 rebounds, 9 assists and 9 steals in the two games.

She again led the Spartans to a perfect 3-0 record the week of January 5, 2009 with wins over Herkimer CCC, Tompkins-Cortland CC, and Onondaga CC. In those three contests she scored 82 points, pulled down 13 rebounds, dished out 12 assists, and collected 15 steals. She also currently leads the nation in scoring average at 25.5 points per game. Teammates Corissa Quattrini (#8 - 19.5 ppg) and Shakeema Green (#42 - 13.5 ppg) are also among the nation's statistical leaders in scoring.



## **Nursing News**

It is often stated that the one constant in education is change-the Nursing Program is no exception. Linda Alfieri was appointed director of nursing in January 2008. Mary Driscoll has joined the faculty as a full-time member, co-teaching first level courses with Linda MacKay. Cheryl Foster and Brenda Forrest teach second level courses and Dr. Jane Kiernan coordinates the Nursing Lab. Alfieri states, "Cayuga's nursing faculty is our program's number one asset."

Several initiatives have been implemented in the program:

- The Auburn Campus Nursing Lab has doubled in space as T-109 has been converted into a four patient unit with a Nurses station.
- The department applied for and received \$100,000 from the SUNY High Needs Initiative grant to create a Nursing Lab at the Fulton Campus.
- A Fast Track Evening Weekend program is now offered at the Fulton Campus. A cohort of 20 students started in January 2009 and will graduate in 17 months in May 2010.
- Each nursing course is web-enhanced by the Angel Learning Management System. This allows students the opportunity to use their computers to access test grades, course forms, supplemental learning materials, and communicate with their instructors.
- Curricular changes include a new required one credit course, Nursing Success Strategies. This course is designed to support the student's success in the rigorous nursing curriculum.
- The program is seeking continuing accreditation from the National League for Nursing Accrediting Commission. The accreditation team will be visiting in early February. This voluntary accreditation process promotes innovation and excellence within a nursing program.
- Cayuga graduates continue to exceed the National Council Licensure Exam (NCLEX) state and national passing rates. The class of 2008 achieved a passing rate of 92.3%.

Cayuga's nursing graduates identify the department's faculty and high standards as the strengths of the program. Alfieri states, "Cayuga's nursing program is committed to the preparation of graduates qualified to practice safely and competently in the complex health care environment. The reputation of a 'Cayuga Nurse' continues to excel. Feedback from employers reinforces the excellent reputation of our graduates."

The National Association for the Education of Young Children (NAEYC) Commission on Early Childhood Associate Degree Accreditation has granted accreditation to three associate degree programs in New York state – Cayuga Community College, SUNY Cobleskill and Schenectady County Community College. These three colleges are the first in New York to be granted accreditation for their early childhood degree programs, and each joins only 48 other colleges across the country who have earned the distinction.
